# **CLEARANCE PROCESS INSTRUCTIONS**

You are being considered for a volunteer opportunity that has direct contact with children as it pertains to the Child Protection Services Law (defined as "the care, supervision, guidance or control of children or routine interaction with children). These clearances must be completed before you may volunteer in this capacity. **New clearances must be obtained every five years.** 

Due to the revisions of Act 153 of 2014 we are required to obtain three types of clearances:

#### 1. ACT 34 - PA STATE POLICE CRIMINAL RECORD CHECK

Go to <a href="https://epatch.state.pa.us/Home.jsp">https://epatch.state.pa.us/Home.jsp</a>. There is no fee for volunteers. Verification may be obtained immediately or could take 2-3 weeks to review. Once received, applicants MUST provide the LifePath Christian Ministries with the original clearance form. The original clearance will be copied and returned to the applicant.

#### 2. ACT 151 - PA CHILD ABUSE HISTORY CLEARANCE

Go to <a href="https://www.compass.state.pa.us/CWIS">https://www.compass.state.pa.us/CWIS</a>. You will need to create an account first. After creating your account you will receive an email with your password in order to log in. Please be sure to select the appropriate type of clearance for volunteers. There is no fee for volunteers. Verification can take up to 14 days and you can choose to receive notification via email, mailed to your home address or both. Once received, applicants MUST provide the LifePath Christian Ministries with the original clearance form. The original clearance will be copied by John Ellis and returned to the applicant.

\*\*\*VOLUNTEERS WHO HAVE LIVED IN PENNSYLVANIA CONTINUOUSLY FOR THE LAST 10 YEARS ARE NOT REQUIRED TO UNDERGO #3, AS LONG AS YOU AFFIRM IN WRITING THAT YOU HAVE NOT BEEN CONVICTED OF A FELONY OR SEX CRIME WITHIN THE PREVIOUS FIVE YEARS (SEE ATTACHED WAIVER ON THE NEXT PAGE).\*\*\*

### 3. ACT 114 - FBI FEDERAL CRIMINAL HISTORY CLEARANCE (Fingerprinting):

- a. Applicants MUST register online. Go to www.pa.cogentid.com and click on PA Department of Public Welfare on the first screen.
- b. There is a fee of \$27.50 for the fingerprint clearance.
- c. Applicant should either print out the **registration confirmation number** or, if they do not have access to a printer, they should record the number in a safe place.
- d. **Once registered,** you may have your fingerprints taken at the location of your choice **No appointments are necessary.**Please check the website for each location's hours.
- e. Applicants must provide proof of identity upon arrival at the Fingerprint Center (a state issued driver's' license, state I.D. card, passport, etc.).
- f. The Department of Public Welfare will receive the Federal Criminal History Record from the FBI, and will return the record to you. The record will be printed on standard 8.5" x 11" paper.
- g. Once received, applicant MUST provide LifePath Christian Ministries with the original clearance

## FBI BACKGROUND CHECK: WAIVER OF REQUIREMENT

Pursuant to Act 153 of 2014 and as amended, any volunteers who have lived in the Commonwealth of Pennsylvania continuously for the last 10 (ten) years are not required to undergo the Federal Criminal History Record Check including the full set of fingerprints.
